Names rather than numbers have been chosen to designate the new Divisions and Groups. They are not meant to be fully comprehensive but to describe the main activities within each Division or Group.

Services provided by the present Appleton Administration Division will continue until further notice at Ditton Park. The recruitment of staff to mobile grades will however be organized by the Personnel Group at Chilton as will combined Rutherford and Appleton Laboratories Local Review Boards.

SIGNING POWERS

- l. Part of the system of financial management at the Laboratories is dependent on the commitment of funds by named people on particular projects within maximum amounts. The purpose of this notice is to restate the general rules and fix new limits in terms of grades. RLN 7/78 is hereby cancelled.
- Division Heads may authorize commitments up to £10,000. In the absence of the Division Head, a deputy may sign up to the limit of £10,000 but must clearly indicate that he is signing on behalf of the Division Head. Division Heads may authorize members of their Division to sign on specific projects; these will normally be to a maximum for the appropriate grade as set out on page 2 of this Notice. Where it is considered appropriate, Division Heads may authorize university staff to sign on specified projects up to the limit of a staff member occupying an equivalent position. There is no difference in signing powers as between Capital and Non-Capital at below Director level.
- 3. Officers carrying out work on the N12's authorized in accordance with the above may enter into commitments within the N12 total up to twice the financial limit appropriate to their grade. The signatures of these officers, although not nominated to commit on the particular projects, will be acceptable provided that the N12 number is quoted.
- 4. The Chairman of the Accommodation and Building Sub-Committee may authorize commitments up to £25,000 for schemes which have been dealt with through that Committee.
- 5. Warrants on running contracts may be signed in accordance with the delegations issued by the Superintending Officer of the contract. Warrants on UKAEA contracts for outside manufacturing in excess of £2,000 in value required UKAEA Contracts Section approval before issue.
- 6. Existing lists of names with signing levels against projects will continue until further notice at the higher levels. Requests for changes in the signing power list should be made in writing to Finance and Accounts Group and must be authorised by the Division Head.
